

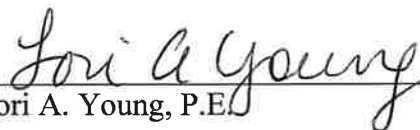
AFFIDAVIT OF CONTIGUITY

Before me, the undersigned Notary Public, personally appeared Lori A. Young, P.E., who, being first duly sworn upon her oath, states as follows:

1. Affiant is a professional engineer licensed in the State of Indiana and is employed as a Regional Manager with Curry & Associates, now part of Fleis & VandenBrink, with a business address of 110 Commerce Drive, Danville, Indiana 46122.
2. Affiant has knowledge of the location, boundaries, and configuration of certain real estate located in Adams Township, Decatur County, Indiana, which is the subject of a Petition for Voluntary Annexation to the Town of St. Paul, Indiana (the "Territory"), and has reviewed mapping, parcel data, and geographic information system (GIS) data from Decatur County, Indiana, including Beacon GIS, sufficient to form the opinions set forth herein.
3. The Territory is commonly known as E. School Street, St. Paul, Indiana 47272, and is identified as Parcel Number 16-05-03-000-007.020-001.
4. Based upon Affiant's review of the property boundaries, applicable mapping, and GIS data, and the corporate limits of the Town of St. Paul, Indiana, the Territory is contiguous to the existing corporate boundaries of the Town of St. Paul, Indiana, as that term is defined in Indiana Code § 36-4-3-1.5.
5. Specifically, at least one-eighth (1/8) of the aggregate external boundaries of the Territory coincide with the existing boundaries of the Town of St. Paul, Indiana.
6. A map depicting the Territory and its relationship to the corporate boundaries of the Town of St. Paul, Indiana, derived from Decatur County GIS (Beacon), is attached to the Petition for Voluntary Annexation as Exhibit "B" and supports the conclusions stated herein.
7. This Affidavit is made in support of the Petition for Voluntary Annexation filed with the Town of St. Paul, Indiana, pursuant to Indiana Code § 36-4-3-5.1.
