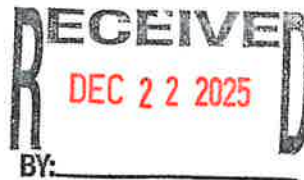

It is now time to appoint your 2026 representative to the Southeastern Indiana Regional Planning Commission (SIRPC) Board of Directors. Although state statute requires that the board be made up of 2/3 local elected officials, the appointing authority may designate a non- elected community representative if desired. The Town of St Paul has 1 appointee to the SIRPC Board. Currently, your appointee on our board is Joshua Sangl.

Board meetings of SIRPC provide an opportunity for county representatives to keep abreast of community development initiatives as well as to collaborate with neighboring local elected officials and community leaders. The SIRPC full board meets quarterly on the second Wednesday of the months of January, April, August, and October. An Executive Board is elected by the full board and is comprised of a representative of each member county and the Commission officers. The Executive Board meets monthly on the morning of the second Wednesday of every month.

Throughout its history, the SIRPC has had the privilege of serving as a development partner in a large number of regional and individual community initiatives. For your information and review, we have enclosed a partial listing of projects that SIRPC staff has assisted in both obtaining financing for and successfully implementing. Successful teamwork between SIRPC staff and Southeastern Indiana communities has resulted in over \$68 million of outside investment in just the last 10 years.
